



# 2025 Residential Ground Source Heat Pump Rebate Registration Form for Existing Homes

ENERGIZE CONNECTICUT<sup>SM</sup>



Valid for Eversource or United Illuminating (UI) ("Companies") residential electric service customers ("Customer") who purchase and install a qualifying high-efficiency ground source heat pump ("Equipment") for an existing home on or after January 1, 2025, through December 31, 2025. All 2025 residential ground source heat pump rebate registrations ("Application"), along with required documentation, must be postmarked no later than February 28, 2026. Equipment must be ENERGY STAR<sup>®</sup> certified. Equipment must be installed by a contractor participating in the Energize CT Heat Pump Installer Network and must replace oil, propane, natural gas or electric resistance (baseboard) as the primary heating system.\* Projects are randomly selected for inspection. Refusing a post installation inspection could result in forfeiting your rebate. **Customer must submit this form along with the required documents by mail or online before installation to qualify for the heat pump rebate. For quicker processing, online submission at [EnergizeCT.com/Rebates](https://EnergizeCT.com/Rebates) is recommended.**

\*A heat pump is an electrical system, so running one will add to your electrical use. In many cases, additional electrical use is offset by savings elsewhere, such as a propane or oil heating fuel bill. If you're adding a heat pump where there was no cooling source before, it will increase your electrical use.

**TERMS AND CONDITIONS**

**ELIGIBILITY:** Rebates are available to Eversource or United Illuminating (UI) ("Companies") residential electric service customers ("Customer"). Equipment must be ENERGY STAR® certified and installed by a contractor participating in the Energize Connecticut<sup>SM</sup> Heat Pump Installer Network. Customer must replace existing oil, propane, natural gas or electric baseboard heating systems as the primary heating source to qualify. Eligible homes include existing single family and one to four unit multifamily structures.

**EQUIPMENT REQUIREMENTS:** Ground source heat pumps must be ENERGY STAR certified and qualified, listed with and certified by the Air Conditioning, Heating, and Refrigeration Institute (AHRI). All systems must meet the minimum efficiency requirements on this form.

**REBATE FORM:** This rebate form must be filled out completely, truthfully, and accurately. The Customer must date and submit the completed form along with all required documentation for specific rebates and/or incentives. By submitting the Application, the Customer agrees to abide by these Terms and Conditions. Program is subject to change without prior notice, including rebates and incentive levels.

**TIME LIMIT:** Qualifying "Equipment" must be purchased and installed between January 1, 2025, and December 31, 2025. Rebate forms must be postmarked by February 28, 2026.

**PAYMENTS:** From the time the rebate form is processed and approved, please allow 90 days for payment. Payment processing will take longer if information or documentation is missing. Please contact Resource Innovations at 888-855-0282 to inquire about the status of your Application.

**GEOGRAPHIC REQUIREMENTS:** Offers valid only for residential electric Customers of the Companies.

**REBATE LIMITATIONS:** This rebate is only available to existing account holders and is not applicable to new construction projects. Installation must be completed by a participating Energize CT Heat Pump Installer Network contractor to be eligible for rebates. This rebate is only available to residences that are occupied full time during the winter heating season. This rebate may not be combined with any other utility or energy efficiency service provider offer for the same equipment. Rebate amount not to exceed the cost of the total Equipment and installation and may be subject to change without notice.

**PROOF OF PURCHASE:** A copy of the Customer's invoice itemizing the purchased Equipment must accompany each Application. The invoice must indicate the Equipment make and model numbers, installation date and address, total install cost, and proof of payment.

**APPROVAL AND VERIFICATION:** The Companies reserve the right to conduct field inspections to verify installations prior to payment. Failing to complete an inspection when selected will result in forfeiting your rebate.

**TAX LIABILITY:** The Companies will not be responsible for any tax liability that may be imposed on the Customer or contractor as a result of the payment of rebates.

**ENDORSEMENT:** The Companies do not endorse any particular manufacturer, product, system design, or technology in promoting these offers.

**LIMITATION OF LIABILITY:** The Companies' and their rebate administrator's liability is limited to paying the rebate and incentive specified.
