
Submittal of participant application to Eversource and/or Avangrid



Define scope of work and receive letter of agreement




Install energy efficiency upgrades

# **Environmental Justice Communities**

- Environmental Justice Block Groups

- Enhanced incentive towards electricity and gas savings and improvements
- \$0.10/kWh or 10% to cost cap
- \$2/CCF to cost cap
- Eligible energy efficiency measures:
  - HVAC equipment and controls
  - Building envelope
  - Enhanced lighting
  - Appliances

#### **Central Heat Pumps**

\$250/ton (MR) or \$500/ton (IE) for Heat Pump Equipment Upgrade PTAC to PTHP: \$500/unit MR and \$750/unit IE

#### **Heat Pump Water Heating**

	Dwelling Unit	Central
Market Rate	\$650/unit	\$1,000-1,400/unit
Income Eligible	\$750/unit	\$1,200-1,600/unit

#### Lighting

	Standard Lighting	Enhanced Performance Lighting	Qualifying fixtures/control strategies
Market Rate	\$.20/kWh	\$.45/kWh	Luminaire Level Lighting Controls (LLLC)
Income Eligible	\$.25/kWh	\$.50/kWh	Occupancy sensor, daylighting, high end trim

- Existing screw in base fixtures are not eligible for retrofit or replacement.
- Enhanced lighting refers to LED fixtures with digital control and wireless accessibility to commission the luminaires individually and/or collectively into a zoned system.
  - A minimum of two control strategies must be implemented at least 80% of the connected lighting load to qualify
