I hope everyone had a nice (if not overly hot) weekend.

Our Manager of DR Programs, Paul Gray, had a few additional comments regarding this study. One is of VERY HIGH importance and should be addressed by the evaluation committee ASAP.

Please see the 3rd and highlighted comment below. DNV should anonymize the vendors in the market share sections prior to publishing the final report.

- Related to the issue with the Uplight marketplace thermostats not being dispatched because they weren't assigned to a child group, we went in and added them to the Residential Central AC child group so this issue can be avoided in the future.
- Related to the point that 26% of enrollments were missing account numbers, our Automated Enrollment
 Verification (AEV) process only pulls account numbers into an enrollment if there's a match as part of the AEV
 process. For those customers that were not initially matched (but ultimately enrolled), the Avangrid team would
 need to manually input the account number when as part of the manual enrollment process.
- Figure 6 details the enrollment levels by vendor, our partner agreements require that market share information such as this is not shared publicly. Can you ask DNV to update this graphic and related narrative to anonymize the vendors (e.g. Vendor 1, 2, 3)?
