

2025 Residential Air Source Heat Pump Rebate Registration Form for Existing Homes

Valid for Eversource or United Illuminating (UI) ("Companies") residential electric service customers ("Customer") who purchase and install a qualifying air source heat pump ("Equipment") to replace an existing heat pump, to add to a previously unconditioned space or when used for cooling only. This rebate is valid for installations in existing homes completed between January 1, 2025, and December 31, 2025. Air Source Heat Pump Rebate Registrations ("Application") with required documentation must be postmarked no later than February 28, 2026. Equipment must be ENERGY STAR® Cold Climate certified and installed by a contractor participating in the Energize CT Heat Pump Installer Network. If replacing natural gas, oil, propane or electric resistance as the primary heating source, please consult the 2025 Residential Energy Optimization Rebate Registration Form or EnergizeCT.com/energy-optimization. Projects are randomly selected for inspection. Refusing a post-installation inspection could result in forfeiting your rebate. Please note Customer must submit this form along with the required documents by mail or online before installation to qualify for the heat pump rebate. For quicker processing, online submission at EnergizeCT.com/Rebates is recommended.

ELIGIBILITY: Incentives are available to Eversource or United Illuminating (UI) ("Companies") residential electric service customers ("Customer"). Equipment must be installed by a contractor participating in the Energize Connecticut^{5M} Heat Pump Installer Network. Eligible homes include existing single family and 1–4 unit multifamily structures. Please be sure to verify your model(s) at: EnergizeCT.com/HPQPL

Equipment Requirements: Air source heat pumps and integrated controls must be listed on the Energize Connecticut Heat Pump Qualified Product List. Refer to Energize CT.com/HPQPL

Rebate Form: This Application must be filled out completely, truthfully, and accurately. The Customer must date and submit the completed Application along with all required documentation for specific rebates and/or incentives. By submitting the rebate Application, the Customer agrees to abide by these Terms and Conditions. Program is subject to change without prior notice, including rebates and incentive levels.

Time Limit: Qualifying Equipment must be purchased and installed between January 1, 2025, and December 31, 2025. Rebate forms must be postmarked by February 28, 2026.

Payments: From the time the rebate Application is processed and approved, please allow 90 days for payment. Payment processing will take longer if information or documentation is missing. Please contact Resource Innovations at 888-855-0282 to inquire about the status of your Application.

Geographic Requirements: Offers valid only for residential electric Customers of the Companies.

Rebate Limitations: This rebate is only available to existing account holders and is not applicable to new construction projects. Installation must be completed by a participating Energize CT Heat Pump Installer Network Contractor to be eligible for rebates. This rebate is only available to residences that are occupied full time during the winter heating season. This rebate may not be combined with any other utility or energy efficiency service provider offer for the same equipment. Rebate amount not to exceed the cost of the total equipment and installation and may be subject to change without notice.

Proof of Purchase: A copy of the Customer's invoice itemizing the purchased Equipment must accompany each rebate Application. The invoice must indicate the Equipment make and model numbers, installation date and address, total install cost, and proof of payment.

Approval and Verification: The Companies reserve the right to conduct field inspections to verify installations prior to payment. Failing to complete an inspection when selected will result in forfeiting your rebate.

Tax Liability: The Companies will not be responsible for any tax liability that may be imposed on the Customer or contractor as a result of the payment of rebates.
