



Valid for Eversource or United Illuminating (UI) residential electric service customers ("Customer") who purchase and install a qualifying air source heat pump ("System") for an existing home on or after January 1, 2024, through December 31, 2024. Air Source Heat Pump Rebate Registrations ("Application") with required documentation must be postmarked no later than February 28, 2025. Equipment must be ENERGY STAR® certified and must meet the minimum requirements on the rebate form. Minimum requirements differ depending on the type of air source heat pump. Equipment must be installed by a contractor participating in the Energize CT Heat Pump Installer Network and must replace oil, propane, natural gas, or electric resistance (baseboard) as the primary heating system.* Please note: As of July 1, 2024 Eversource and UI customers are required to submit this form and required documents by mail or online before beginning install in order to be eligible for a heat pump rebate. Online submission at EnergizeCT.com/Rebates is encouraged for faster turnaround time.

*A heat pump is an electrical system, so running one will add to your electrical use. In many cases, that additional electrical use is offset by savings elsewhere, such as a propane or oil heating fuel bill. If you're adding a heat pump where there was no cooling source before, it will increase your electrical use.

ELIGIBILITY: Incentives are available to Eversource or United Illuminating (UI) ("Companies") residential electric service customers ("Customer"). Equipment must be installed by a contractor participating in the Energize Connecticut Heat Pump Installer Network. Customers must replace existing oil, propane, natural gas or electric baseboard where propane, oil, or natural gas will remain in use. Eligible homes include existing single families and 1-4 unit multifamily structures. Please be sure to verify your model(s) at: EnergizeCT.com/HPQPL

Equipment Requirements: Air source heat pumps and integrated controls must be listed on the Energize Connecticut Heat Pump Qualified Product List. Refer to EnergizeCT.com/HPQPL

Rebate Form: This rebate form must be filled out completely, truthfully, and accurately. The Customer must date and submit the completed form along with all required documentation for specific rebates and/or incentives. By submitting the rebate form, the Customer agrees to abide by these Terms and Conditions. Program is subject to change without prior notice, including rebates and incentive levels.

 $\textbf{Time Limit:} \ \textbf{Qualifying units for equipment rebate must be purchased and installed}$ between January 1, 2024, and December 31, 2024. Rebate forms must be postmarked by February 28, 2025.

Payments: From the time the rebate form is processed and approved, please allow 90 days for payment. Payment processing will take longer if information or documentation is missing. Please contact Resource Innovations at 888-855-0282 to inquire about the status of your application.

Geographic Requirements: Offers valid only for residential electric Customers of the Companies.

Rebate Limitations: This rebate is only available to existing account holders and is not applicable to new construction projects. Installation must be completed by a participating Energize CT Heat Pump Installer Network contractor to be eligible for rebates. This rebate is only available to residences that are occupied full time during the winter heating season. This rebate may not be combined with any other utility or energy efficiency service provider offer for the same equipment. Rebate amount not to exceed the cost of the total equipment and installation and may be subject to change without
