The Connecticut Energy Efficiency Board (EEB) invites you to participate in the upcoming public input session (virtual only) focusing on the development of the 2025-2027 Conservation and Load Management (C&LM) Plan. The September 4th session will focus on feedback related to the "Second Draft of the 2025-2027 C&LM Plan (v. 8/7/24)". A subsequent session will be noticed once the Third Draft is released. The EEB will be voting on the budget and savings tables included in the Plan during the September 11, 2024 EEB Meeting and on the overall Plan at the October 9, 2024 EEB Meeting. For historical context, the summary table below provides a chronology of past public input opportunities pertaining to the ongoing Plan development process:

Established through CGS 16-245m, the EEB is comprised of 12 voting members representing business and consumer interests as well as state agencies, and five non-voting representatives of the state's electric and gas utilities. It advises and assists the utilities in the development and implementation of Connecticut's energy efficiency and demand response plans.

The EEB and DEEP welcome and encourage input as part of the collaborative process with the electric and gas utility companies, the CT Green Bank, interested stakeholders and the public to develop the 2025-2027 Plan. Public input will inform the EEB and DEEP on updates to the next

Please include your name, company, and electronic copies of your remarks, and/or a PowerPoint presentation if you plan to use one. A record of public input becomes part of the 2025-2027 Plan itself. Therefore, it is important that commenters provide written input, preferably in advance of the session. Presentations during the Public Input Session should be no longer than seven minutes.

Stakeholders may also submit written comments for consideration by submitting them to the Executive Secretary at EEB Secretary@EnergizeCT.com by September 4th. Stakeholders do not need to attend the Public Input Session, nor do they need to provide their comments during the Public Input Session, for comments to be considered.
