



2024 Residential Ground Source Heat Pump Rebate Form for Existing Homes

Valid for Eversource or United Illuminating (UI) residential electric service customers ("Customer") who purchase and install a qualifying high-efficiency ground source heat pump ("System") for an existing home on or after January 1, 2024 through December 31, 2024. All 2024 Residential Ground Source Heat Pump Rebate requests ("Application") along with required documentation must be postmarked no later than March 31, 2025. **Equipment must be installed by a contractor participating in the Energize CT Heat Pump Installer Network in the service territory of a participating utility and must replace oil, propane, natural gas or electric resistance (baseboard) as the primary heating system.**

TERMS AND CONDITIONS

ELIGIBILITY: Rebates are available to Eversource or United Illuminating (UI) ("Companies") residential electric service customers ("Customer"). Equipment must be ENERGY STAR certified and installed by a contractor participating in the Energize Connecticut Heat Pump Installer Network. Customers must replace existing oil, propane, natural gas or electric baseboard heating systems as the primary heating source to qualify. Eligible homes include existing single families and one to four unit multifamily structures.

EQUIPMENT REQUIREMENTS: Ground source heat pumps must be ENERGY STAR certified and qualified, listed with and certified by the AHRI. All systems must meet the minimum efficiency requirements on this form.

REBATE FORM: This rebate form must be filled out completely, truthfully and accurately. The Customer must date and submit the completed form along with all required documentation for specific rebates and/or incentives. By submitting the rebate form, the Customer agrees to abide by these Terms and Conditions. Program is subject to change without prior notice, including rebates and incentive levels.

TIME LIMIT: Qualifying units for equipment rebate must be purchased and installed between January 1, 2024 and December 31, 2024. Rebate forms must be postmarked by March 31, 2025.

PAYMENTS: From the time the rebate form is processed and approved, please allow 90 days for payment. Payment processing will take longer if information or documentation is missing. Please contact Resource Innovations at 1-888-855-0282 to inquire about the status of your Application.

GEOGRAPHIC REQUIREMENTS: Offers valid only for residential electric Customers of the Companies.

REBATE LIMITATIONS: This rebate is only available to existing account holders and is not applicable to new construction projects. Installation must be completed by a participating Energize CT Heat Pump Installer Network Contractor to be eligible for rebates. This rebate is only available to residences that are occupied full time during the winter heating season. This rebate may not be combined with any other utility or energy efficiency service provider offer for the same equipment. Rebate amount not to exceed the cost of the total equipment and installation and may be subject to change without notice.

PROOF OF PURCHASE: A copy of the Customer's invoice itemizing the purchased equipment must accompany each rebate form. The invoice must indicate the equipment make and model numbers, installation date and address, total install cost and proof of payment.

APPROVAL AND VERIFICATION: The Companies reserve the right to conduct field inspections to verify installations prior to payment.

TAX LIABILITY: The Companies will not be responsible for any tax liability that may be imposed on the Customer or contractor as a result of the payment of rebates.

ENDORSEMENT: The Companies do not endorse any particular manufacturer, product, system design or technology in promoting these offers.

LIMITATION OF LIABILITY: The Companies' and their rebate administrator's liability is limited to paying the rebate and incentive specified. The Companies and their rebate administrator are not liable for any consequential or incidental damages or for any damages in tort connected with or resulting from participation in these offers.
