The Connecticut Energy Efficiency Board (EEB) and the Department of Energy and Environmental Protection (DEEP) invite you to the 2024 Public Input Sessions for the development of the 2025-2027 Conservation and Load Management (C&LM) Plan. Based on feedback received during the February 2024 Equity Workshop, two virtual sessions are being offered in order to accommodate varying schedules of potential attendees – one during mid-day and another held after typical work hours. As a result, the sessions are expected to be duplicative; however, attendees are welcome to attend either session or both sessions.

During these input sessions the EEB's Technical Consultants will review the potential Plan priorities that are under consideration and will seek feedback and recommendations from the public. For reference, the potential priorities highlighted during the <u>March EEB Meeting Plan Priorities Presentation</u> included:

- 1) Expanding DEI Efforts
- 2) Developing Decarbonization Goals
- 3) Building Electrification Readiness
- 4) Expanding Electrification
- 5) Bundling Energy Efficiency with Distributed Energy Resources
- 6) Coordination With Federal Funding and Local Energy Policies

Established through CGS 16-245m, the EEB is comprised of 12 voting members representing business and consumer interests as well as state agencies, and five non-voting representatives of the state's electric and gas utilities. It advises and assists the utilities in the development and implementation of Connecticut's energy efficiency and demand response plans.

The EEB and DEEP welcome and encourage input as part of the collaborative process with the electric and gas utility companies, the CT Green Bank, interested stakeholders and the public to develop the 2025-2027 Plan. Public input will inform the EEB and DEEP on updates to the next 3-year Plan that will take effect in 2025. Therefore, it is important that commenters provide written input, preferably in advance of the session. Presentations during the Public Input Session should be no longer than seven minutes.

Stakeholders do not need to attend the Public Input Sessions, nor do they need to provide their comments during the Public Input Sessions, for comments to be considered.
